- 2. That the City Administrator be tasked with preparing a request that the City of Longwood receive Sister City status with a Soviet and/or East European City.
- 3. That the City Commission state publicly that they support the reforms being made in Communist dominated countries which will ultimately lead to freedom and self determination for every person.


